## Purpose

- Mission: The Nassau County Health Improvement Coalition's mission is to improve the health status of the Nassau County community by addressing and monitoring priority health and wellness through a collaborative, community-driven process.
- Our Vision: The Nassau County Health Improvement Coalition will improve the level of health in Nassau County through awareness, education, partnership, prevention, service delivery, and policy development so that individuals achieve their potential to live healthy, active lives.



# History of NCHIC

- Began as Nassau County Health Improvement Advisory Council
- ▶ July 1997, FDOH Bureau of Chronic Disease awarded Community Intervention Program Grant to Nassau County Health Department to address preventing chronic disease.
- In 1999, additional funding was awarded to prioritize health initiatives and to form a Health Improvement Advisory Council (NC-HIAC)
- Conducted Community Needs Assessments in 2001 and 2005 with Health Planning Council
- Grant support and various wellness projects
- ▶ In 2007, changed from Advisory Board to Health Department to Community Health Improvement Coalition



### NCHIC Goals

- Strategic Planning and Focus on Obesity Prevention and development of Adult and Pediatric Work Groups – including stress management, physical activity, nutrition, program development, and recruitment
- Nutrition and Physical Activity projects, school-based projects, print media health education columns, employee wellness
- Ongoing partnership networking & collaboration
- Plan and implement health promotion programs for the community and uses data obtained from Community Needs Assessment
